**Methodology:** The study is obtained mainly through theoretical approaches, hypotheses and simulation methods developed in the group. The research uses techniques such as regression analysis, empirical statistical analysis and graphic representation, analysis and comparison.

### Doctoral thesis details (2012, habil.) - abstract:

The dissertation solves the complex problem related to the instruments efficiency of financial regulation of the insurance market in Ukraine. The new financial regulation instruments, which describe the competitiveness of the insurance market on different security levels, have been offered. The concept of insurance market financial regulation has been elaborated. There has been proved the scale effect in insurance and the actual distributions of insurers depending on their revenues and assets has been found.

The work presents the conceptual ways of creation and development of microinsurance in Ukraine as the new socially oriented regulation instrument.

It is shown that the increase of the financial regulation efficiency can be reached using reduced taxes and differentiated taxation of insurers profits within different types of activities.

The increase of the financial regulation efficiency concerns also the obligatory accumulation funds of preventive measures. In this context the ways of regulation of the insurance fraud counteraction on microeconomical level of the insurer, on the regional and macroeconomical levels of the country have been recommended.
